NOTICE OF RATE ADJUSTMENT

NOTICE OF RATE ADJUSTMENT

This notice is to inform you of a rate adjustment that will take place on July 1, 2024. On January 19, 2022, North Coast County Water District (NCCWD) Board of Directors approved series of rate adjustments over a period from February 1, 2022 through July 1, 2025. NCCWD Resolution No. 1133, adopted on January 19, 2022, establishes future water rate adjustments and also provides for a pass through of SFPUC's wholesale water rate increases and reductions that are different from the wholesale water rates projected at the time the Resolution was adopted. For the water rate increase that will go into effect on July 1, 2024, the water usage charges originally adopted by NCCWD will be increased by seventy-five cents (\$0.75) per unit because the wholesale water rate is more than projected. The tables below show the following bimonthly supply and distribution charges, fire protection service charges, and water usage charges including: (1) the charges that are currently in place [note that the water usage charges that went into effect on July 1, 2023 included a \$0.56 per unit SFPUC wholesale rate pass through]; (2) the charges that were adopted by NCCWD by Resolution No. 1133 without the July 1, 2024 SFPUC pass through, shaded blue; and (3) the charges that will go into effect on July 1, 2024 that include the \$0.75 SFPUC wholesale rate pass through, shaded yellow.
